**I. Parties**

The parties to this agreement are The University of South Dakota (USD) and Lake Area Technical Institute (LATI).

**II. Purpose**

The purpose of this agreement is to:

- A. have a signed articulation agreement that addresses the varying needs of students and complementary nature of the institutions' programs;
- B. provide increased educational opportunities for students from South Dakota and the region;
- C. extend and clarify educational opportunities for students;
- D. provide LATI students who have completed the AAS degree in Occupational Therapy Assistant an opportunity to earn a Bachelor of Science degree with a major in Health Sciences.

**III. Academic Program**

**IV. Pathway One: Reverse Articulation (completing years one and two at USD, years three and four at LATI, and transferring LATI credits back to USD for completion of degree)**

- A. Students will complete the required Health Science major courses through the University of South Dakota during the first two years of their education. During the third year of their education, they will enter the Occupational Therapy Assistant program at LATI and complete the requirements for the AAS in Occupational Therapy Assistant at the end of the fourth year.
- B. Upon successful completion of the requirements of the AAS degree in Occupational Therapy Assistant, the student will transfer back to USD and apply for graduation. At that time, USD will accept a block of 46 technical course credits in transfer. In addition to the Occupational Therapy Assistant technical course block credits, general education coursework that is equivalent to Regental courses will be transferrable and accepted by USD.
- C. USD will waive the graduation requirement that 16 of the last 32 credits for the baccalaureate degree must be earned as institutional credit.
- D. Students must meet all other Board of Regents and university graduation requirements in order to receive a degree.

**V. Pathway Two: Forward Articulation (completing the AAS in Occupational Therapy Assistant at LATI and transferring to USD to complete the Bachelor of Science in Health Sciences)**

- A. Upon successful completion of the requirements of the AAS in Occupational Therapy Assistant, students may transfer to USD to complete the BS in Health Sciences. At that time, USD will accept a block of 46 technical course credits from the AAS degree in Occupational Therapy Assistant. Students must successfully complete the AAS degree in Occupational Therapy Assistant from LATI prior to transferring to USD for the technical course credits to be accepted. Transferable general education coursework in addition to the 46 technical course block credits will also be accepted.
- B. Students will complete the requirements for the Health Sciences major and any other general education or free elective requirements that remain unsatisfied.
- C. Students must meet all Board of Regents policies and university graduation requirements in order to receive a degree.

**VI. Additional requirements**

- A. Students transferring coursework from LATI must have a cumulative GPA of 2.0 on a 4.0 scale.
- B. In accordance with BOR policy 2:28, students must demonstrate satisfactory performance in writing, mathematics, reading, and science reasoning as evidenced by receiving a passing score on all sections of the Collegiate Assessment of Academic Proficiency (CAAP) exam. In accordance with the Regental policy, students must take the exam during the first semester of enrollment at USD after completion of 48 passed credit hours. Students must have completed a specified 18 credit hours of general education courses prior to taking the exam.

**VII. Obligations**

Both parties agree to confer with each other on a yearly basis regarding changes in curricula involved in this articulation agreement.

**VIII. Modification**

This agreement may be modified from time to time by the South Dakota Board of Regents and Lake Area Technical Institute.

**IX. Incorporation of terms in master agreement.**

The parties have entered into the present agreement pursuant to the agreement of December 14, 2004 between the Watertown Board of Education on behalf of Lake Area Technical Institute and the South Dakota Board of Regents on behalf of Black Hills State University, Dakota State University, Northern State University, the South Dakota School of Mines and Technology, South Dakota State University and The University of South Dakota. This agreement shall be subject to all terms and conditions stated in the December 14, 2004 agreement.

**X. Termination**


This agreement may be terminated by the University of South Dakota upon one year's written notice to Lake Area Technical Institute. Student(s) enrolled in the program at that time shall be allowed to complete the program.


**XI. Effective Date of Agreement:**


Start date of the fall 2010 term at USD and LATI. The agreement applies to students who graduated from LATI in 2000 or later.






